**SAFETY TECHNICIAN, Springfield, MA**  
BAYSTATE HEALTH

Under direction of Safety Director, provide technical support services to the Safety program at the Baystate Medical Center and other Baystate Health System entities as required. Monitor injury and illness data trends, track safety performance indicators and produce reports for use by the Director for the administration of a comprehensive safety program to limit the risks of occupational illness and injury and loss of physical property at Baystate Medical Center to the lowest levels that are reasonably achievable.

Manage the collection, storage and off-site disposal of all chemical waste; perform the required inspections of waste storage areas and emergency equipment; distribute and track hazardous waste manifests; and, maintain all required records. Participate in safety and hazardous materials audits and emergency preparedness activities.

Administer and maintain the electronic Material Safety Data Sheet database.

Coordinate and conduct environmental sampling. Take samples and arrange for appropriate laboratory analysis and/or perform limited analysis in-house. Maintain the record of all personal sampling performed.

Serve as member of the Chemical Review Committee and other safety related committees as needed. Supervise contract personnel.

Function in a consulting role to other BHS entities as needed.

Observe all health and safety requirements.

This description covers the essential functions of the position. Incumbent is expected to perform other similar and related duties as assigned. Management has the right to change or add to the job responsibilities at any time.

Qualifications: A two year degree in a technical discipline, preferably safety related, chemistry or engineering and 0 - 3 years experience in a safety or industrial hygiene related position.

**Deputy Fire Chief (USP II), Storrs, Connecticut**

University of Connecticut Fire Department  
Division of Public and Environmental Safety  
Reporting to the University Fire Chief or other designated University official, the Deputy Fire Chief is accountable for managing fire suppression and prevention activities, code compliance

inspections and enforcement, hazardous materials mitigation, crisis response, origin and cause investigations and emergency medical services for the University Community. The Deputy Fire Chief establishes and implements policies, rules and regulations and procedures necessary for the efficient operation of the Fire Department and is responsible for the proper management, hiring, evaluation, training and promotion for all direct reports in the Fire Department.

Minimum Qualifications to Apply: Ten (10) years of fire experience that includes considerable knowledge of fire fighting, fire prevention practices, code compliance inspection and enforcement procedures, and fire investigation procedures; five (5) years experience working as a supervisor and leader in a fire service organization; and must possess Valid Motor Vehicle Drivers License.

Additional Qualifications Required: Excellent leadership ability; considerable knowledge of emergency medical techniques and hazardous materials emergency mitigation procedures; excellent interpersonal skills including the ability to interact effectively in a culturally and ethnically diverse community; ability to communicate effectively verbally and in written communications; considerable ability to evaluate emergency situations and develop effective courses of action to same; ability to utilize FireHouse software or similar database applications; ability to utilize Microsoft Office applications, i.e. Word, Excel and Access; ability to manage and work within a budget and promote cost effectiveness. An equivalent combination of experience and training which provides the required knowledge, skills and abilities may be considered.

The additional qualifications required, listed above, will be evaluated through a series of interview questions and practical real time exercises.

Preferred Qualifications: Four-year or advanced degree from accredited college or university; Fire Officer Certifications (I, II, III, IV) pursuant to NFPA 1021 accreted by the National Board on Fire Service Professional Qualifications (NPQS) and/or the International Fire Service Accreditation Congress (IFSAC); completion of the State of Connecticut Fire Marshal Pre-Certification Program with current continuing education hours; State of Connecticut or National Registry Emergency Medical Technician – Basic (EMT-B) or State of Connecticut or National Registry Emergency Medical Technician – Paramedic (EMT-P); Hazardous Materials Technician Certification pursuant to NFPA 472 (NPQS and or IFSAC) or EPA or OSHA Hazardous Materials Technician; and current or honorably discharged member of a United States military service.

Physical and Background Requirements: Position requires general good health and incumbent must possess and retain sufficient strength, stamina, agility, visual and auditory acuity necessary to perform the duties of the class. External candidates may be required to pass a pre-employment background and physical examination.

Salary: Target salary is \$101,000. A comprehensive benefit package includes medical, dental, life insurance, pension plan, vacation, sick leave accrual, and tuition waiver program for the employee and dependants. This is a full-time permanent position with the hours of 8:00 a.m. to 5:00 p.m., Monday through Friday. Occasional weekend and irregular hours may be required as needed to support the demands of operations and/or emergency situations. Incumbents in this class may be exposed to some danger of injury or loss of life during fire fighting and rescue operations, significant mental stress of responding to life and death emergencies and disagreeable conditions including exposure to weather, loud noises and chemicals.
