Manage the General Workplace Health and Safety Inspection Program. Conduct ergonomic assessments in industrial and laboratory environments. Conduct project plan reviews. Act as subject matter expert in areas of industrial hygiene and provide consultation to University faculty and staff. Respond to emergencies involving hazardous materials and direct remediation efforts.
