This is a managerial position largely carried out in an office environment, though the EHS Director shall regularly tour facilities to personally inspect operations and communicate with different departments. Beyond compliance, the EHS Director develops and implements programs and processes that support corporate social responsibility (CSR) priorities related to the environment, health and safety, and the achievement of related, multi-year goals.

Minimum qualifications for an EHS director position are a bachelor's degree in environmental health and safety management or related field and at least ten years of on-the-job experience in implementing environmental, health and safety programs. The position requires strong managerial, communication, and analytical skills, as well as the ability to work in both a team and independently. The successful applicant will also have strong program management skills and experience, and will have demonstrated the ability to guide, educate and influence colleagues to adopt the necessary processes and

behaviors that are hallmarks of a deep culture of environmental management, health and safety. The candidate must also be able to handle high-stress emergency situations. Relevant OSHA and ISO certifications are strongly preferred.
