Safety Manager, Springfield, MA
Springfield Water & Sewer Commission

The Springfield Water and Sewer Commission (SWSC), a regional authority responsible for providing water and sewer services to a population of 250,000 residents is seeking an experienced **Safety Manager** to be a part of its core leadership team .

Responsibilities include managing all occupational health, hazard compliance/mitigation, risk assessment, safety trainings/recommendations, and maintenance of a health and safety plan, construction site safety assessment plans, as well as emergency response for a staff of 250 employees across multiple locations in Western Massachusetts.

ESSENTIAL DUTIES AND RESPONSIBILITIES include but not limited to the following:

- o Recommends, develops, administers and manages all safety training for the Commission employees
- o Performs safety training at all 6 SWSC locations for field employees. Develop training topics and materials, maintain regular schedule, and track attendance.
- o Develops and submits recommendations to maintain compliance with local, state, federal, and industry safety recommendations. Develops and maintains detailed records including locations and inspections of potentially hazardous areas or materials.
- o Will oversee the Commissions' Health and Safety Committee which has union and management representation.
- o Will assist with the coordination and investigation of workers compensation claims and will be responsible for coordinating random controlled substance testing for the Commissions CDL operators.
- o Conducts field site safety inspection program to ensure worker safety at SWSC work locations and to ensure compliance with state and federal regulations. Utilizes knowledge of DigSafe laws and road work zone regulations under MUTCD to ensure work site safety.
- o Conducts work place/accident investigations and assist in preparation of reports of findings and recommendations .
- o Maintains current information and changes in state and federal regulations, such as the Occupational Safety and Health Administration (OSHA) regulations, Omnibus Transportation Employee Testing Act (OTETA), Department of Homeland Security (DHS), and other safety regulations and performs related work as required or assigned.
- o Responds to emergency events and situations in the field and advises SWSC management safety considerations associated with them. Also assists the Emergency Response, IPP & FOG Manager in preparing and maintaining emergency response plans and associated SOPS.

EDUCATION AND EXPERIENCE:

- Must have a four (4) year college degree in occupational/industrial safety or a related field; or acceptable equivalent credits or experience.
- Must have six (6) years of relevant supervisory or managerial experience in the safety and training fields.
- Must possess or be willing to obtain OSHA Public Sector Safety and Health Fundamentals Certification within 1 year of hire.
- Experience in a municipal water treatment/distribution environment strongly preferred.
- Experience in a construction environment preferred

**Environmental Health & Safety (EHS) Manager, Chicopee, MA
Cardinal Health**

Responsible for the development, implementation, monitoring and assessment of programs and systems designed to reduce risks to the Company. Facilitates compliance with all federal, state and local environmental, health and safety regulatory requirements, corporate standards, and related Plant procedures. Manages all environmental projects associated with air, water and waste at the site. This function involves extensive recordkeeping, monitoring, report preparation, inspection, procedure development and revision, training, and extensive verbal and written communication at all levels of the organization and with interfacing agencies and organizations. Responsible for ensuring all reporting is conducted timely.

Essential Functions

Minimize hazardous conditions from human error, equipment and machine operations, which may lead to human injury and/or property damage through elimination, engineering, administration and/or personal protective equipment (PPE) control measures.

Coordinate a system of internal inspections and audits to identify unsafe conditions and behaviors and regulatory non-compliance, and coordinate or monitor corrective actions. Implementation, reporting and auditing of all existing air discharge permits; waste water discharge permits; storm water discharge permits; hazardous waste and non hazardous waste programs and associated programs. This includes annual review of all applicable regulations.

Adhere to plant/corporate policies/procedures, department safety and environmental regulations, Good Manufacturing Practices (GMPs), and ISO13485 standards. Audit and maintain current existing ISO 14001:2004 certified environmental management system.

Have sufficient knowledge of all environmental compliance reports with the appropriate agencies (internal and external). File RCRA, TSCA, EPCRA, SARA and MADEP required paperwork.

Review all accident reports for thoroughness of investigations and adequacy or corrective actions, and investigate all work-related accidents, incidents, and occupational illnesses. Maintain related records, and perform analysis to identify trends and causes. Make recommendations to prevent reoccurrence.

Devise and coordinate safety awareness programs and conduct plant wide safety meetings.

Establish and implement plant safety training requirements and coordinate training efforts, including safety orientation, user-level training and periodic refresher training. Evaluate and report occupational illness, injury, and incident trends to facility management staff.

Prepare and submit all required compliance reports, including OSHA & BLS reporting and recordkeeping and corporate safety periodic reports.

Develop and maintain facility emergency response procedures.

Review and approve appropriate personal protective equipment for plant applications.

Perform safety acceptance inspections of new or modified equipment to ensure appropriate safety features and hazard controls are in place.

Develop and execute waste minimization or risk mitigation project.

PREFERRED MINIMUM REQUIREMENTS:

Bachelor's degree from an accredited college or university in Occupational Safety, Health or Environmental Engineering or related field.

Preferred Experience

Minimum 5-8 years work experience with responsibilities in occupational safety, health and/or environmental compliance is required, preferably in a manufacturing environment.

Skills/Qualifications

Professional certification as CSP or CIH is preferred. Incumbent may be asked to pursue professional certification.

Detailed knowledge of federal, state, and local EHS statutory requirements is essential.
