Emergency Preparedness Manager, Newton, MA

Description: Reports to the Newton-Wellesley Hospital (NWH) Chief Operating Officer (COO) with oversight and support from the Partners Healthcare System (PHS) Emergency Preparedness Senior Manager, Medical Director and PHS EP Senior Advisor. Manages the execution of all planning, mitigation, response and recovery aspects of an effective emergency management program for NWH and licensed off sites. Manages the planning, coordination, maintenance, and updating of the Emergency Operations Plan which addresses internal and external event responses. Serves as a subject matter expert for practical and regulatory issues related to hospital emergency management, and leads and supports all Emergency Preparedness committees at NWH. Works with the COO as well as other NWH and PHS leaders to develop strategic direction for the program, identify opportunities to integrate and enhance NWH programs and overall PHS Emergency Preparedness, and execute tactics to implement identified priorities.

Qualifications: Bachelor's Degree in Emergency Management or a related field; minimum of 3-5 years of directly related experience and experience in a healthcare setting strongly preferred. Experience and working knowledge of the Hospital Incident Command System (HICS) and applicable aspects of safety management in a complex environment. Training or experience in project management, strong leadership, communication and operational problem solving skills required.

The Environmental Compliance Manager administers and maintains environmental and regulatory compliance programs to protect or improve air, land and water resources in order to provide a clean and healthful environment. The work requires a professional knowledge of the applicable regulations, principles, methods and techniques of engineering concerned with facilities and systems for controlling pollution and protecting quality of resources and the environment. An understanding and the ability to utilize pertinent aspects of chemistry, biological sciences and public health that pertain to the control or elimination of pollutants are also major functions.

ESSENTIAL DUTIES AND RESPONSIBILITIES:

- Apply engineering competence with specialized knowledge of environmental, chemistry, and/or biological science and with familiarity of current environmental regulations.
- Develop, update, and maintain compliance documentation for required regulatory programs related to the facility infrastructure associated with cold storage distribution centers including but not limited to the Risk Management Plan (RMP), Process Safety Management (PSM), Stormwater, Spill Prevention (SPCC), Emergency Response, Tier II, RCRA, HACCP, and Food Safety.
- Regulating and enforcing environmental engineering policies, programs or activities by establishing standards, promoting improvements, evaluating compliance and, if necessary, directing action to secure satisfactory results.
- Prepare and submit necessary filings either in-house or with the use of specialized consultants.
- Interface with regulatory agencies and divisional personnel to direct environmental efforts in the divisions.
- Participate in annual environmental compliance audits.
- Provide environmental guidelines and assistance in training at the divisional level as required.
- Interact with outside vendors as necessary to ensure compliance with regulatory requirements.
- Perform other related duties as assigned.

EDUCATION/EXPERIENCE REQUIRED:

- B.S. degree in environmental engineering or a related science field with at least three years of experience in that field.

- Three years of experience in the environmental field and experience working with local regulatory agencies are preferred.
- Excellent written, oral and computer skills required.
- Ability to work in a team environment across multi-site organization is required.

REQUIREMENTS/WORK ENVIRONMENT:

Physical demand requirements include those that primarily sedentary in nature with occasional walking and standing on concrete floors. Must be able to work in a very busy environment while maintaining flexibility. Environment can be tense at times depending on the nature of the business at any given time.
