


UST Program Changes



UST Regulation Amendment

There have been two significant changes to the Connecticut Underground Storage Tank Requirements. Just issued CTDEEP Underground Storage Tank regulations (RCSA 22a-449(d)-101 et seq.) require each UST Facility (federally regulated non-onsite heating oil tanks) to have Class A, B and C Operators. Federally regulated USTs include those containing gasoline, diesel, waste oil, and heating oil storage for resale. These regulations were promulgated to comply with the Federal Energy Policy Act of 2005.

The Class A Operator has overall regulatory responsibility for the UST program, Class B Operators have regulatory responsibility for the operation of the USTs, and Class C Operators are to be familiar with the UST system, alarm panels and proper response to different alarms. Class A and B Operators have to pass an International Code Council Exam. A Class C operator can be trained by a Class A or B operator.

The name(s) of Class A and B Operators have to be submitted to CTDEEP on the form at: http://www.ct.gov/dep/lib/dep/underground storage tanks/statement of training.pdf

The form, which has to be completed for each tank, has to be signed by the Facility Owner or Operator.

The regulation also implements requirements for new UST installations, including leak-proof piping sumps and under-dispenser containment, monthly tank inspections, and expands the definition of regulated substances.

The deadline for complying with this regulation was August 8, 2012, which was only two months after regulation issuance, due to delays in finalization.

Phase-out of Financial Assurance Requirements

June's special session passed Public Act 12-1, **AN ACT IMPLEMENTING PROVISIONS OF THE STATE BUDGET FOR THE FISCAL YEAR BEGINNING JULY 1, 2012**. Section 263 of the Act addresses the elimination of the underground storage tank petroleum clean-up program financial assurance mechanism. Financial Assurance is required for "federally regulated" USTs impacted by the regulation amendment discussed above. Financial assurance of \$500,000 per occurrence and \$1,000,000 annual aggregate for potential corrective action in response to a release, and for third party bodily injury / property damage can be provided by a variety of mechanisms such as a financial guarantee, surety bond, liability insurance, or by a state mechanism, which is presently the UST petroleum storage tank clean-up program.

The Act indicates persons who operate USTs on 1 to 5 separate parcels of real property can use the clean-up program as financial assurance up to October 1, 2013. Persons who operate USTs on more than five separate parcels of real property can use the program up to October 1, 2012.



Construction Stormwater Permit

The CTDEEP has proposed extending the existing Construction Stormwater General Permit until September 30, 2013. The General Permit is set to expire September 30, 2012. CTDEEP is in the process of modifying this General Permit and this extension of the existing Permit will allow
